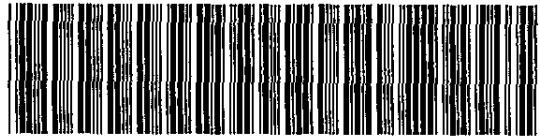


FIRST: THE Articles of Organization were filed on September 15, 2005, effective September 15, 2005 and assigned documents number L05000090765.
