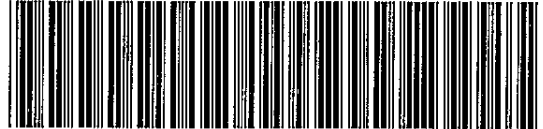

**ARTICLES OF ORGANIZATION
of**

COMMON SENSE MANAGEMENT CONSULTING, L.L.C.

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company being formed is:

COMMON SENSE MANAGEMENT CONSULTING, L.L.C. ,
a Single-Member Florida State Limited Liability Company
("L.L.C.") or ("Company")

**ARTICLE II
ADDRESS**

The mailing address and the street address of the principal office of the Limited Liability Company is: 2646 S.E. 19th Court, Miami-Dade County, Homestead, Florida 33035.

**ARTICLE III
PURPOSE**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

The Company designates 2646 S.E. 19th Court, Homestead, Florida 33035, as its street address of the initial registered office, and names Jerome Williams as the Company's initial registered agent at that address to accept service of process within the State of Florida.

**ARTICLE V
DURATION**

The period of duration for the Limited Liability Company shall commence on the date these Articles have been filed with the Division of Corporations, Florida Department of State, and shall have perpetual existence, in accordance with the terms of the Company's Regulations contained in its Operating Agreement. However, upon any termination event, the existence and business of the

Company may be continued with the consent of the Member of the Company, or by amendment of these Articles of Organization providing for the continued existence of the Company.

ARTICLE VI MANAGEMENT

The business and management of the Company shall be conducted, carried on, and managed by the original single member and original single manager, as prescribed by and provided in the Regulations of the Company, as contained in its Operating Agreement. Such Manager-Member shall have all of the rights and responsibilities, more fully described in the Regulations of the Company, as contained in its Operating Agreement. The name and address of the initial Member-Manager is: Jerome Williams, 2646 S.E. 19th Court, Homestead, Florida 33035.

ARTICLE VII NAME OF MEMBER-MANAGER

The name and residence address of the initial Member-Manager of this single-member limited liability company is: Jerome Williams, 2646 S.E. 19th Court, Homestead, Florida 33035.

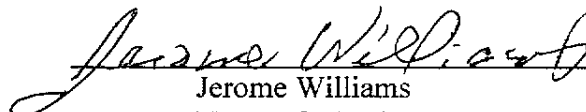
ARTICLE VIII ADDITIONAL MEMBERS

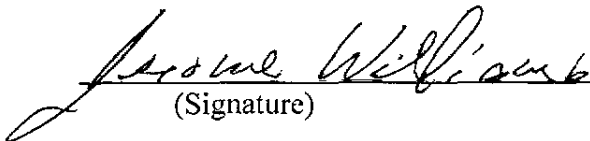

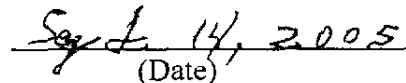
