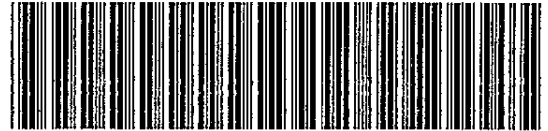

ARTICLES OF ORGANIZATION

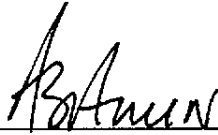
