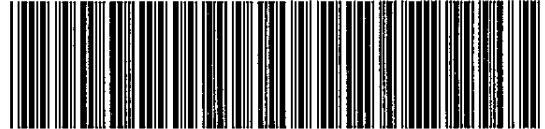

Dear Sir or Madam:

We attempted to file PCKL Partnership, LLC with the Department of State but had the filing rejected because of a Division of Corporations internal rule. As was explained to us, the internal rule states that the Division of Corporations refuses to file articles of organization of a limited liability company that contains the word "partnership" in its name.

As you know, Chapter 608 of the Florida Statutes does not prohibit the name of a limited liability company to contain the word "partnership." Further, the company name, PCKL Partnership, LLC, submitted to the Division of Corporations had the designation "LLC", clearly identifying the type of entity as a limited liability company. Further, Florida Statute 608.406 does not prohibit entities with similar names from registering as a limited liability company.


The name PCKL Partnership, LLC was chosen because it was formerly a general partnership and then converted to a limited liability company. Because the partnership had and continues to do business, the partners wish to keep the original name intact to avoid potential confusion and accounting issues. However, the designation "LLC" was added to the name to adhere to the statutes and disclose that it is a limited liability company.

For the above mentioned reasons, we believe the name PCKL Partnership, LLC may be submitted to the Department of State for filing.






