**ARTICLES OF ORGANIZATION FOR  
FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

**ARTICLE I - NAME**

The name of the professional limited liability company is SMALL BLESSING BIRTH CENTER, PLLC (the "Company").

**ARTICLE II - ADDRESS**

The mailing address of the Company is P.O. Box 08249, Fort Myers, FL 33908. The street address of the principal office of the Company is 6150 Diamond Center Court, Building 400, Fort Myers, FL 33912.

**ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE**

The name and the Florida street address of the registered agent is Fowler White Boggs Banker P.A., 5811 Pelican Bay Boulevard, Suite 600, Naples, FL 34108.

**ARTICLE IV - PURPOSE**

The general purposes for which this Company is organized shall be to render medical services to women, and to do all things in connection therewith that are customarily performed by a licensed physician, an advanced registered nurse practitioner, and a certified nurse midwife under the laws of the State of Florida. In furtherance of its company purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a limited liability company by the Professional Service Corporation and Limited Liability Company Act.

**ARTICLE V - LIMITATION ON MEMBERSHIP**

No one other than an individual who is duly licensed or legally authorized to render licensed medical services in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any

member who becomes legally disqualified to render the medical services set forth in Article IV shall sever all employment with and financial interest in the Company. No member of the Company may sell or transfer his interest in the Company, except to another individual or an organization eligible to become a member of the Company.

#### ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more managers and is, therefore, a manager-managed company. The name and the address of the initial manager of the Company is Richard L. Bloy, M.D., 6150 Diamond Center Court, Suite 400, Fort Myers, FL 33912.
