### AMENDED ARTICLES OF ORGANIZATION

### ADDITIONAL ARTICLES

### VI. MANAGEMENT AND REPRESENTATION

The management, operation and policies of the LLC are vested exclusively in the members. The members shall have the power on behalf and in the name of the LLC to carry out and implement any and all of the objects and purposes of the Company.

The initial members, Gerd Brügel, Sven Nauke, and Sabine Reinhardt are hereby exclusively designated as Managers and Representatives of the LLC. Each member is entitled to solely act on behalf and to legally bind the LLC.

### VII. CAPITAL CONTRIBUTIONS

The initial Members are not required to contribute capital to the Company.

### VIII. <u>ALLOCATIONS</u>

All income will be automatically allocated to the accounts of the initial members in accordance with their membership contributions. If membership contributions are not requested, each member receives an amount of income equivalent to his/her membership interest. An annual member resolution about the allocation of income is not required. Member's who render services to the LLC by a member will receive an income allocation equal to the value of the services provided upfront.

## IX. TRANSFER OF MEMBERSHIP

A transfer of the membership interest in the LLC requires the approval of all LLC members.
