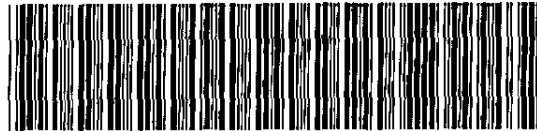

**ARTICLES OF ORGANIZATION OF
SOUTHEAST RADIOLOGY ASSOCIATES, P.L.**

**ARTICLE I
NAME**

The name of the professional limited liability company shall be Southeast Radiology Associates, P.L.

**ARTICLE II
PURPOSES AND POWERS**

The professional limited liability company is authorized to render professional services as permitted by the laws of the State of Florida, as amended from time to time, for a professional limited liability company. MEMBERSHIP




