ARTICLES OF ORGANIZATION

OF

KIRBY-SMITH CAMP, SONS OF THE CONFEDERACY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name

The name of the limited liability company shall be Kirby-Smith Camp, Sons of the Confederacy, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be One Independent Drive, Suite 2600, Jacksonville, Florida 32202.

ARTICLE II

Purposes and Powers
