**ARTICLES OF ORGANIZATION  
OF**

**HARBOR BEACH I, LLC, A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608 Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be HARBOR BEACH I, LLC ("company").

**ARTICLE II -- ADDRESS**

#### ARTICLE VI -- MANAGEMENT

The company shall be managed by the members in accordance with operating agreement adopted by the members for the management of the business and affairs of the company. The operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
