**ARTICLES OF ORGANIZATION
OF
S & S INVESTMENTS OF NORTH FLORIDA, LLC.**

EFFECTIVE DATE

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **S & S INVESTMENTS OF NORTH FLORIDA LLC.** (the "Company").

ARTICLE II - PURPOSE

1. The Company may engage in any lawful business.

ARTICLE III - ADDRESS

The street address of the principal office of the Company is 830 S. 3rd Street, Suite 108, Jacksonville Beach, Florida 32250. The mailing address of the Company is 830 S. 3rd Street, Suite 108, Jacksonville Beach, Florida 32250.

ARTICLE IV - DURATION

The Company shall commence its existence effective 8:00 a.m. on September 6, 2005. The Company's existence shall be perpetual, unless the Company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the state of Florida is Samuel L. LePrell, Suite 201, St. Mark's Place, 1930 San Marco Boulevard, Jacksonville, Florida 32207.

ARTICLE VI - CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company \$1,000.00 in cash.

ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the unanimous consent of all of the members or as provided in the Regulations of the Company.

ARTICLE VIII - ADMISSION OF NEW MEMBERS

Except as set forth in the Regulations, no additional members shall be admitted to the Company except with the unanimous written consent of all the Class A members of the Company and on the terms and conditions as shall be determined by all of the Class A members. A member may transfer his or her or its interest in the Company as set forth in the Regulations, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the Class A members of the Company other than the member proposing to dispose of his or her or its interest approve of the proposed transfer by written consent.

ARTICLE IX - CLASSES OF MEMBERSHIP

The Company shall have two (2) classes of Membership, Class A and Class B. The Class A and Class B Memberships shall have the same rights and obligations, except that Class B Members shall have no voting rights.

ARTICLE X - MEMBER'S RIGHT TO CONTINUE BUSINESS

So long as the Company continues to have at least one (1) remaining Member, the Company shall not be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company. Provided however, if there are no remaining Members, the Company will not be dissolved and will not be required to be wound up if, within ninety (90) days, after the occurrence of the event that terminated the continued Membership of the last remaining Member, the personal representative or other legal representative of the last remaining Member agrees, in writing, to continue the Company and agrees to the admission of the personal representative of such Member or its nominee or designee to the Company as a Member, effective as of the occurrence of the event that terminated the continued Membership of the last remaining Member.

ARTICLE XI - MANAGEMENT

The Company shall be managed by its Managers in accordance with the Regulations and the Member Control Agreement, if any, adopted by the members for the management of the business and affairs of the Company. The Member Control Agreement and the Regulations may contain any provisions for the operation, regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. As of this date, there are no Class B Members. The name and address of the sole Class A member of the Company is:

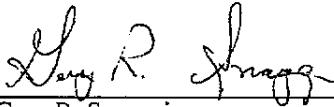

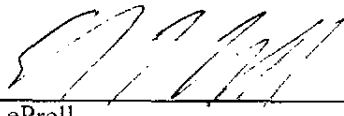
