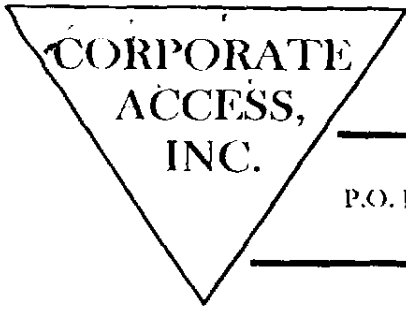

ARTICLE VII - AMENDMENT


