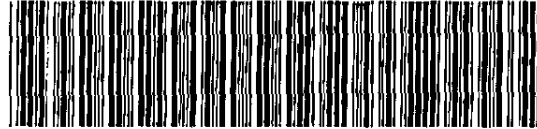

The undersigned, FRANK MAGGIO, as the subscriber to these Articles of Organization, hereby present these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

**ARTICLE I.  
NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be MAGGIO BRADENTON, LLC

**ARTICLE II.  
TERM OF EXISTENCE**

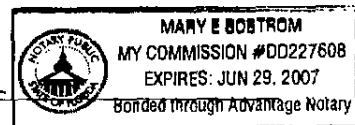
