The name of the limited liability company is COMPUTING TECHNOLOGIES ASSOCIATES, LLC (the "Company").

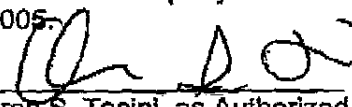
ARTICLE II – ADDRESS

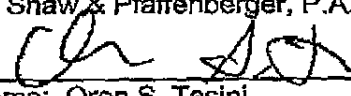
