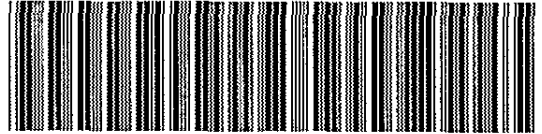

NS3 RX - MIAMI, LLC**

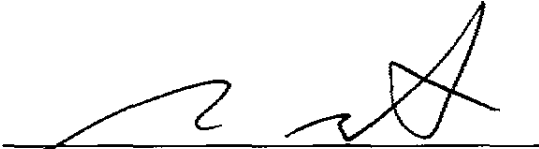

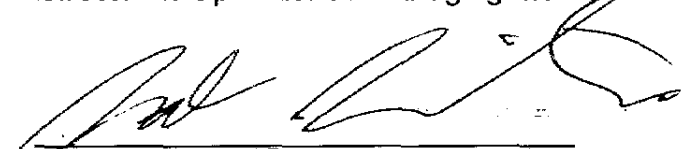
SECOND: Articles of Organization are hereby amended by changing the name of the Corporation to: **Commcare Pharmacy – MIA, LLC**

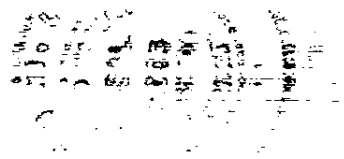
