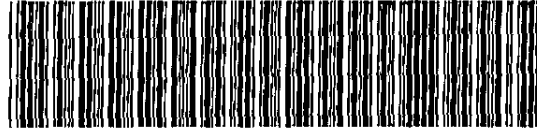

THE UNDERSIGNED, has executed the following document as incorporation of the above named Limited Liability Company, organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as organizer, and those of the Limited Liability Company, are to be determined in accordance with the laws of the State of Florida

ARTICLE I – NAME

New members can be admitted to the company with full rights of membership upon the unanimous consent of the existing members.

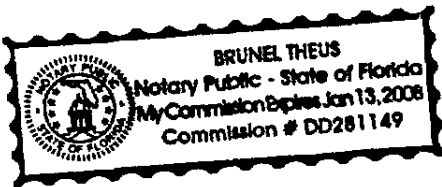

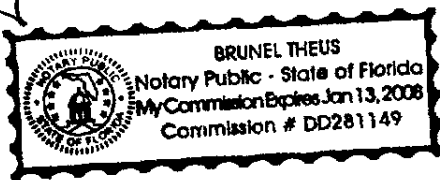
