The name of the Limited Liability Company is CROCKER PARTNERS LLC.

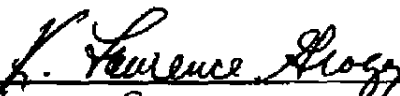

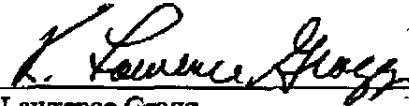

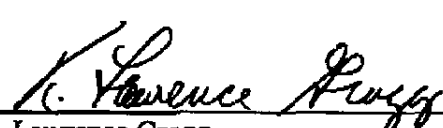
