To Whom It May Concern:

Last June 2006 I suffered a severe stroke. I tried to continue to operate the business, but due to my condition I realized I was not doing an adequate job. As a result the firm was not heading in a positive direction. In August, I refunded the initial investment of my two financial partners Mr. Kirby and Mr. Solaroli \$7,500 each. O' Shaughnessy Investments, LLC a minority partner is still owed \$5,000 for their investment, and the company owes a \$10,000 balance on a credit card used for purchasing supplies.

Our main client, GrayHawk Investments still owes LSP about \$17,000 to \$20,000. As of this date they have outstanding invoices that have not been paid to Light Speed Partners, LLC.

In January of 2007 I notified Mr. Kirby by —mail of these invoices, and another \$3,400 owed to LSP by Access Limited. Light Speed Partners, LLC discontinued paying my salary in October of 2006.

I have been under medical care by the Veterans Administration, and I have not been able to Conclude this business of resignation and closing the books due to my illness. Now that I am feeling a little better, I felt that I had to take action to remove myself from the company and allow Mr. Kirby to take full and complete ownership.
