

WHEREAS, On November 8, 2006, an Agreed Order was entered appointing Margaret Smith to act as the Receiver for Florida's Best Cars and Trucks, LLC (the "LLC"). STIPULATION FOR END OF RECEIVERSHIP AND DISSOLUTION OF FLORIDA'S BEST CARS AND TRUCKS, LLC

The parties to this cause hereby stipulate as follows:

- 1. On November 8, 2006, an Agreed Order was entered appointing Margaret Smith to act as the Receiver for Florida's Best Cars and Trucks, LLC (the "LLC"). The Order gave the Receiver full and exclusive power, duty and authority to administer and manage the business affairs of the LLC, to marshal and safeguard the assets of the LLC, to defend the LLC in multiple lawsuits and to take whatever actions are necessary for the LLC.
- 2. The Receiver has approved of a settlement agreement between the LLC and Somerset Creamery Limited Partnership ("Somerset"), the terms of which are outlined in this Stipulation.
- 3. The Receiver requests an order of the Court discharging her Receivership and dissolving the LLC upon completion of the items identified in paragraph 4 below.
 - 4. The assets of Florida's Best Cars and Trucks, LLC shall be distributed as follows:



- a. The Receiver shall pay all outstanding invoices to the Receiver and her counsel from the funds on deposit in the LLC's account at RBC Centura Bank in Jupiter, Florida;
- b. The Receiver shall disburse \$5,000 of the funds on deposit in the LLC's account at RBC Centura Bank in Jupiter, Florida to Joseph Strong in full satisfaction of his claims as a creditor of the LLC;
- c. All remaining property, assets, and estates of every kind, including all records, titles and other evidences of the assets and property of the LLC shall be distributed to Somerset in full satisfaction of its claims as a creditor of the LLC.
- Somerset will be solely responsible to address any claims, known or unknown, against the LLC that arise. Somerset shall hold \$3,000 in escrow in the trust account of Robert B. Cook, P.A. for a period of one year as a means to satisfy any claims made against the LLC. If, after one year, no claims have been made against the LLC, Robert B. Cook, P.A. may disburse the funds held in escrow to Somerset. The Receiver makes no warrants or representations regarding any known or unknown claims of the LLC and is fully released from the responsibility of addressing any claims that arise. Somerset shall defend and indemnify the LLC and its members, Joseph Strong and Loretta Van Horn, in the event any claims relating to obligations or debts of the LLC are brought against the LLC or its members.
- 6. Joseph Strong shall be responsible for the completion and filing of all necessary tax reporting on behalf of the LLC. Both the Receiver and Somerset are released of any responsibility relating to the federal and state tax reporting of the LLC.
 - 7. The parties have entered into the General Release attached as Exhibit A.
 - 8. The parties request the Court retain jurisdiction of this matter for all purposes.

GENERAL MUTUAL RELEASE

This General Mutual Release is entered into by Somerset Creamery Limited Partnership, a Nevada limited partnership, Robert B. Cook. Joseph Strong, and Loretta Van Horn (collectively "The Parties"). In consideration of the obligations and other matters set forth herein, The Parties hereby, in their individual and representative capacities, and on behalf of each of their predecessors, successors, parents, subsidiaries, affiliates and assigns,

Do Hereby remise, release, acquit, satisfy and forever discharge each other, the Receiver (Margaret Smith), and professionals hired by the Receiver, and each of their respective predecessors, successors, parents, subsidiaries, affiliates and assigns of and from all, and all manner of, action and actions, cause and causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, damages, judgments, executions, claims, and demands whatsoever, in law or in equity, which the Parties ever had, now have, or which they or any legal representative, successor, or assign of The Parties, hereafter can, shall, or may have against The Parties, for, upon or by reason of any matter, cause or thing whatsoever, from the beginning of the world to the day of these presents, or matters arising from or relating to all claims which were brought, or which could have been brought in the matter of Somerset v. Florida's Best Cars & Trucks, LLC, Case No. 2006-CA-007654 AE in the Circuit Court in and for Palm Beach County, Florida.

This General Mutual Release does not apply to (and specifically excludes) claims that have been brought or which can be brought arising out of the matters set out in the case of *Joseph Strong* v. Robert B. Cook, P.A. and Robert B. Cook, in his capacity as Trustee, Case No. 50-2007-CA-002997-AD in the Circuit Court of the 15th Judicial Circuit in and for Palm Beach County.

This General Mutual Release does not affect the obligations set out in paragraph 5 of the Stipulation for End of Receivership and Dissolution of Florida's Best Cars and Trucks, LLC which states that Somerset will be solely responsible to address any claims, known or unknown, against the LLC that arise. The Parties agree that the Receiver is fully released from the responsibility of addressing any claims that arise and that Somerset shall defend and indemnify the LLC and its members, Joseph Strong and Loretta Van Horn, in the event any claims relating to obligations or debts of the LLC are brought against the LLC or its members.

The parties agree that this General Mutual Release shall be interpreted and construed in accordance with the laws of the State of Florida, and any action to enforce or interpret this General Mutual Release shall be brought only in the County court or the Circuit Court of Palm Beach County, Florida. This General Mutual Release may be executed in any number of counterparts, all of which taken together shall constitute one General Mutual Release, and any party hereto may execute this Agreement by signing any such counterpart.
