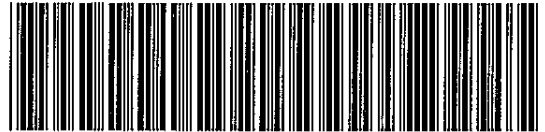

All remaining property and assets have been disbursed to the Company's one member in accordance with his rights and interests.

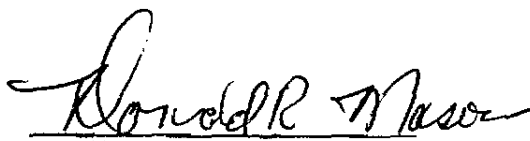
ARTICLE VI
