ARTICLES OF ORGANIZATION OF AMERICAN TITLE LLC

The undersigned, for the purpose of forming a limited liability company under the Florida? Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be AMERICAN TITLE LLC ("Company").
