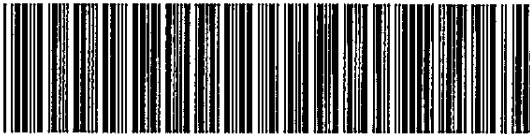

**ARTICLES OF ORGANIZATION OF

Article I

The name of the limited liability company ("Company") is EASTWIND VILLAS, LLC.
