#### ARTICLES OF ORGANIZATION

# ARTICLE I -- NAME

## ARTICLE V -- ADDITIONAL CAPITAL CONTRIBUTIONS

## ARTICLE VI -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company end on such terms and conditions as shall be determined by all the members.
