**ARTICLES OF ORGANIZATION
OF
DR. MARQUES MEDICAL CENTER, P.L.
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, in forming a Florida Professional Limited Liability Company ("Company") under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Organization for such Company:

ARTICLE I

NAME

The name of the Company is Dr. Marques Medical Center, P.L.

ARTICLE II

ADDRESS

ARTICLE III

PURPOSE
