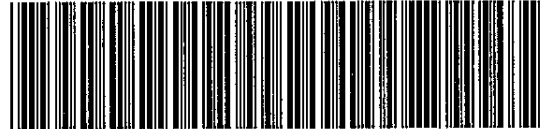

Continuation of Business



ARTICLE 6


Admission of Additional Members





