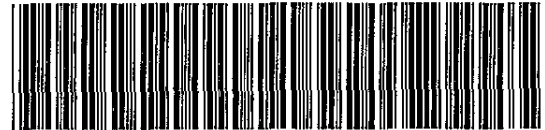

ARTICLES OF ORGANIZATION

FOR

NABB, LLC

The undersigned subscribers to these Articles of Organization, being natural persons competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

ARTICLE I: NAME

The name of this limited liability company shall be:

NABB, LLC

ARTICLE II: ADDRESS

The principal place of business of this limited liability company shall be 315 Sweetwater Circle, Crawfordville, FL 32327, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world. Kurt Hindle shall be a single managing member, entitled to one vote. Karl Hindle shall be a single managing member, entitled to one vote.


