

ARTICLES OF ORGANIZATION VALGARD OF STIRLING, LLC

SECRETARIAN SECRET The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes. acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE L NAME

The name of the limited liability company is Valgard Of Stirling, LLC (the "Company").

ARTICLE IL MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 6840 SW 81 Terrace, Miami, Florida 33143.

ARTICLE III. REGISTERED AGENT AND OFFICE

The name and street address of the initial registered agent of the Company in the State of Florida is Corporation Service Company, 1201 Hays Street, Tallahassee, Florida 32301.

ARTICLE IV. DURATION

ARTICLE VL RESTRICTIONS ON MEMBERSHIP

No additional members shall be admitted to the Company except upon such terms and conditions as set forth in the Operating Agreement. Contributions required of new members shall be determined as of the time of admission to the Company. A member may transfer his, her or its interest in the Company, as set forth in the Operating Agreement, but the transferce shall have no right to participate in the management of the business and affairs of the Company or become a member, unless the other members of the Company other than the member proposing to dispose of his, her or its interest approve of the proposed transfer in accordance with the requirements set forth in the Operating Agreement.
