ARTICLES OF ORGANIZATION OF MR PROJECT, LLC

I, the undersigned natural person of the age of eighteen years or more, acting as organizer of a limited liability company pursuant to Section 608.407 of the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for MR Project, LLC, a Florida limited liability company:

ARTICLE

The name of the limited liability company is MR Project, LLC (the "Company").

ARTICLET

The mailing address and the street address of the principal office of the Company is 402 Hubert Avenue South, Tampa, FL 33609.

ARTICLE III

The street address of the initial registered agent of the Company is 402 Hubert Avenue South, Tampa, FL 33609, and the name of the Company's initial registered agent at such address is Frank A. Boullosa.

ARTICLE IV

The period of the Company's duration is 99 years from the date of filing of these Articles of Organization, unless earlier terminated in accordance with the provisions of its Operating Agreement.

ARTICLE V

The purpose for which the Company is organized is to transact any and all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

ARTICLE VI

The Company will be member-managed in accordance with the terms of the Company's Operating Agreement, and the initial managing-member of the Company, who is hereby authorized to serve as member-manager without limitation on his authority, is as follows:

ARTICLE VII

The Operating Agreement of the Company will be kept with the records of the Company. The Company shall provide a copy of its Operating Agreement without charge to any record holder of a membership interest upon written request addressed to the Company at its principal business office or its registered agent's address.

ARTICLE VIII

The name and address of the organizer of the Company is Frank A. Boullosa, 402 Hubert Avenue South, Tampa, FL 33609.

ARTICLE IX

Subject to the applicable provisions of the Operating Agreement of the Company, the Company may indemnify managers, members, officers, employees, agents and others to the fullest extent permitted by law, as it may be amended from time to time.

ARTICLE X

Under no circumstances shall a member-manager of the Company be liable to the Company for monetary damages for an act or omission in the manager's capacity in managing the business and affairs of the Company, except for liability of a manager for (i) a breach of the manager's duty of loyalty to the Company or its members, (ii) an act or omission not in good faith that constitutes a breach of duty of the manager to the Company or an act or omission that involves intentional misconduct or a knowing violation of the law, (iii) a transaction from which the manager received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the manager's position in managing the business and affairs of the Company or (iv) an act or omission for which the liability of the manager is expressly provided by an applicable statute. If the Florida Limited Liability Company Act, the Florida Business Corporation Act or other applicable law is amended to anthorize action further eliminating or limiting the liability of a member-manager, then the liability of a manager of the Company shall be eliminated or limited to the fullest extent permitted by the Florida Limited Liability Company Act, the Florida Business Corporation Act or other applicable law, as so amended.

Any repeal or modification of the foregoing paragraph by the Company shall not adversely affect any right or protection of a member-manager existing at the time of such repeal or modification.

ARTICLE XI

The Company shall indemnify, save and hold the undersigned organizer of the Company harmless from and against any and all loss, cost, damage, expense (including, without limitation, attorneys' fees and expenses) and liability caused by, resulting from, or arising out of any action taken or authorized by the organizer of the Company in respect of the organization of the Company in what he deemed to be in or not opposed to the best interests of the Company.
