CONTINUATION OF BUSINESS

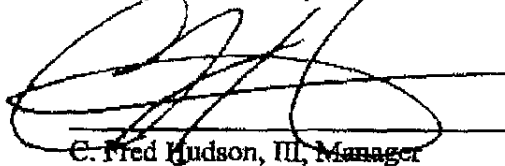

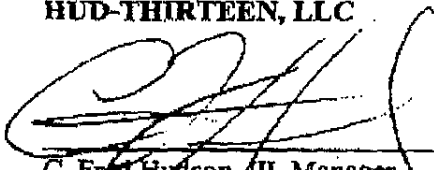
