ARTICLES OF ORGANIZATION SEP 26 A 11:07 OF MOTIVE COMMUNICATIONS, LLC

The undersigned, acting as organizer of Motiv8 Communications, LLC, under the Florida Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:

ARTICLE I NAME

The name of the limited liability company shall be Motiv8 Communications, LLC ("the LLC").

ARTICLE II PERIOD OF DURATION

The period of duration shall commence on October 1, 2005, with the prior filing of these Articles with the Department of State, and shall be perpetual thereon, unless the LLC is sooner dissolved as provided by these Articles of Organization. The effective date of the LLC shall therefore be October 1, 2005.

ARTICLE III PURPOSE

The LLC is organized pursuant to the Florida Limited Liability Company Act to conduct any lawful business, subject to any provisions of law governing or regulating such business within Florida, including the authority to hold, purchase, mortgage, lease and convey real and personal property in Florida. The LLC shall have the powers described in the Florida Limited Liability Company Act and as set forth in the LLC's Operating Agreement.

ARTICLE IV PRINCIPAL PLACE OF BUSINESS



The managers shall not be liable under a judgment, decree or order of the court, or in any other manner, for a debt, obligation or liability of the LLC.
