ARTICLES OF ORGANIZATION

OF

AMPRO Systems, L.L.C.

A Florida Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, subscribe, acknowledge and file these Articles of Organization.

ARTICLE I

The name of the corporation shall be: AMPRO Systems , L.L.C.

ARTICLE II

The mailing address and street address of the principal office of the 100 Fox Fire Circle, Daytona Beach, FL 32119.

ARTICLE III

The company shall commence its existence on the date these company's existence of organization are filed by the Fiorida Department of State. The company's existence shall be perpetual.
