# ARTICLES OF ORGANIZATION OF THE B GALLERY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the Bllowing Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be THE B GALLERY.

## **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be 38E Atlantic Avenue, Delray Beach, Florida 33444

#### ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than June 21, 2040, unless the Company is earlier dissolved as provided in these Articles of Organization.

#### ARTICLE IV - REGISTERED OFFICE AND AGENT
