The undersigned, WILLIAM E. DeCELLE, a natural person competent to contract and a member of PACE INK, LLC, hereby presents these Articles of Organization as the Articles of Organization of PACE INK, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**
