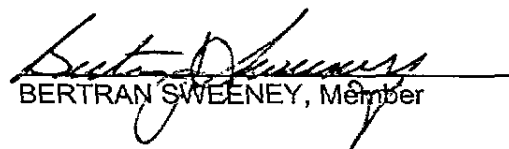
**Article VI**
