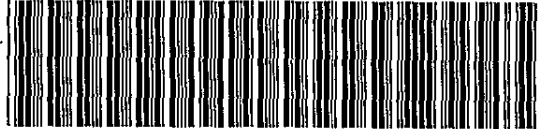

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes acknowledges, and files the following Articles of Organization.

ARTICLE 1 – NAME

The name of the limited liability company shall be Desjardins Services, L.L.C., (“Company”).

ARTICLE 2 – ADDRESS

The principal place of business of the Company in Florida shall be 4007 Broadway, West. Palm. Beach. FL 33425-0201 and the mailing address shall be P.O. Box 201 Boynton Beach. FL 33425-0201.

ARTICLE 3 – EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 – DURATION

Subject to the provisions of Article 9, the Company’s existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE 5 – PURPOSE AND POWERS

The general purpose for which the Company is organized is to purchase and resell property to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the law of the State of Florida.

In event of member's death remaining member must prepare a death grievance that pays the surviving spouse or any other member of the family that they specifically state to be their beneficiary of their share (s) in the organization.

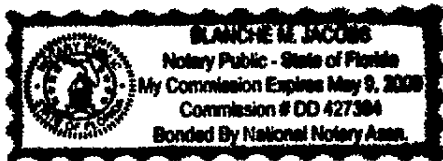
