

ARTICLES OF ORGANIZATION OF CABB Orchard MN Property, LLC a Florida Limited Liability Company



ARTICLE I NAME

The name of this Limited Liability Company is CABB Orchard MN Property, LLC.

ARTICLE II ADDRESS
