BRUHA, a natural person competent to contract and a member of BRUHA INVESTMENTS, LLC, hereby presents these Articles of Organization as the Articles of Organization of BRUHA INVESTMENTS, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE IX - AMENDMENT




