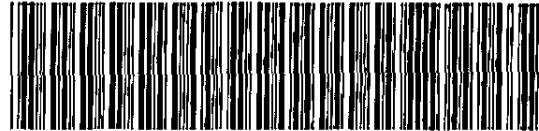



ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **SUNRISE RETREATS, L.L.C.,**

ARTICLE II - ADDRESS



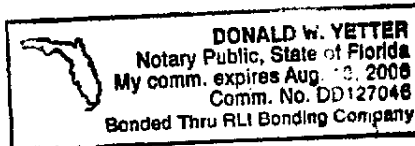
