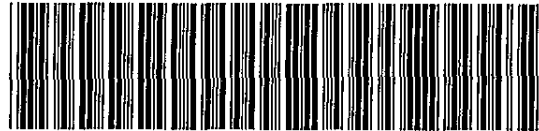


1. **Name:** The name of the limited liability company is SANDRINGHAM GROUP, LLC.
