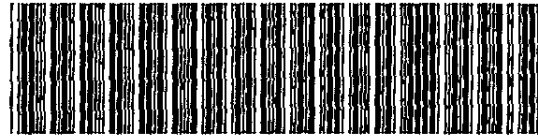

The address of company's principal place of business and mailing address in Florida is Post Office Box 385, Gainesville, Florida 32602.

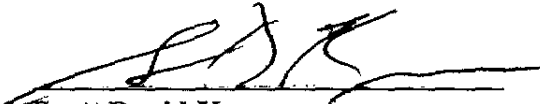

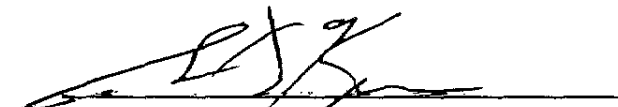
