The Articles of Organization were filed with the Florida Secretary of State on September 29, 2005. The name of the limited liability company is incorrect.

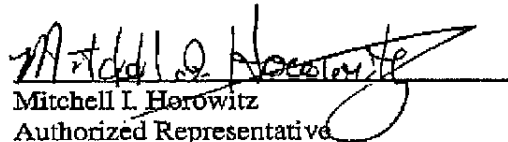
1. The Articles of Organization of Talega Trust Office Property, LLC are hereby corrected by deleting in its entirety the present Article I and by substituting therefor the following:
