**ARTICLES OF ORGANIZATION FOR  
FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE I - Name**

The name of the limited liability company is SWM, LLC.

**ARTICLE II - Address**

The mailing address and the principal office of the limited liability company is:

**ARTICLE III - Duration**

The period of duration of the limited liability company shall be perpetual.

**ARTICLE IV - Purpose**

Pursuant to section 608.409(1), Florida Statutes, the effective date for the beginning existence of the limited liability company shall be September 28, 2005.




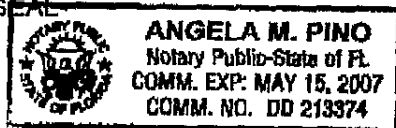
