Pursuant to the Florida Limited Liability Company Act the undersigned, acting as organizer of a limited liability company, hereby adopts the following Articles of Organization for such Company:

Article I <u>Name</u>

The name of the limited liability company is Guettler Brothers Construction, LLC.

Article II Company Existence

The Company's existence shall be perpetual and shall be effective upon the filing of these Articles of Organization with the Florida Department of State.

Article III Units Of Equity Ownership

- Section A. Authorized Units of Equity Ownership. The maximum number of units of equity ownership that Guettler Brothers Construction, LLC is authorized to have outstanding is 1,000 units, all of which shall be identical units.
- Section B. First Lien. The Company shall have a first lien upon the units of any Member for any debt or liability owing by such Member to the Company.
- Section C. Restrictions on Disposition of Units.
