The undersigned, BARBARA ORTH, a natural person competent to contract and a member of ORTH OIL, LLC, hereby presents these Articles of Organization as the Articles of Organization of ORTH OIL, LLC, a limited liability company formed under the provision of Chapter 608, Florida Statutes.

#### ARTICLE I - NAME
