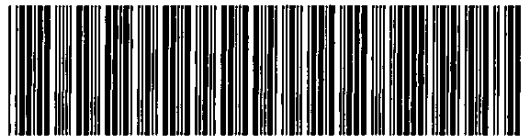

**ARTICLES OF AMENDMENT OF

Pursuant to Section 608.411 of the Florida Statutes, **ZONS PROPERTY 15, LLC**, a limited liability company organized and existing under and by virtue of the laws of the State of Florida (the "Company"), does hereby certify:

1. **Name.** The name of the Company is Zons Property 15, LLC.
2. **Date of Filing of Articles of Organization.** The date of the filing of the Articles of Organization of the Company was September 29, 2005.
3. **Amendment to Company Purpose.** Article III of the Company's Articles of Organization is hereby deleted and replaced in its entirety with the following:
