**ARTICLES OF ORGANIZATION
OF
CONFIDENTIAL PROPERTIES, L.L.C.**

The undersigned member adopts the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is Confidential Properties, L.L.C. (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on September 27, 2105.

**ARTICLE III

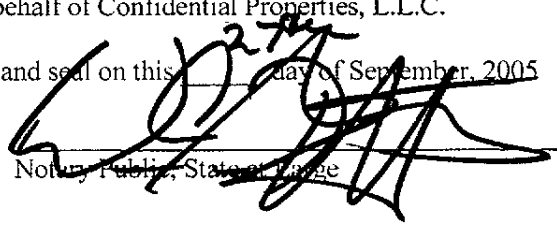

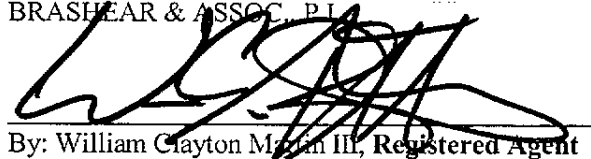
