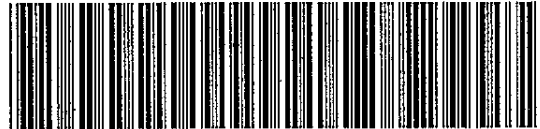

**ARTICLES OF ORGANIZATION OF
MASTERTEK L.L.C.**

TO: THE HONORABLE SECRETARY OF THE STATE OF FLORIDA

The undersigned do hereby make, subscribe, acknowledge and file the following articles for the purpose of becoming a Limited Liability Company under the laws of the State of Florida.

ARTICLE I

The name, principal office street address and mailing address of the Limited Liability Company shall be:

ARTICLE II

The general nature of the business to be transacted by the Limited Liability Company shall be as follows: **Separation systems, Thermal systems, Flow systems, Electrical systems, Processing systems, Control systems, Service systems.**

To conduct the business of manufacturing, buying, selling, and managing real property and to perform all acts as may be necessary to accomplish the foregoing purpose of the company.

To carry on such business at one or more locations in the State for other states and foreign countries, to enter into, make, perform and carryout contracts of every kind and for any lawful purpose with any person, firm association or corporation.

To issue bonds, debentures or obligations of the company from time to time for any of the objects and purposes of the company, and to secure the same by mortgage, pledge deed of trust or otherwise.

To buy, sell issue, lease, manufacture, and generally trade in all kinds of goods, wares and merchandise at wholesale and retail: to purchase and acquire, sell lease, deal and trade in real property of every class and description whether as principal or its own account or as agent, factor, or broker for others.

To purchase or otherwise deal in all kinds of property of whatsoever nature, whether real, personal or mixed, or any interest or rights therein without limits as to amounts; to buy, sell, assign.

Convey and cancel liens upon personal property and real estate of every kind and nature whatsoever, to act as broker or agent for the purchase, sale, leasing and management of real state and the negotiating of loans; to draw, accept endorse discount and deliver bills of exchange, promissory notes, bonds, debentures and other negotiable instruments of whatsoever nature, and to secure the same by mortgage on its property or otherwise.

To do all such things as are incidental or conducive to the premises, and to do all and everything necessary, suitable, convenient, or proper for the accomplishment of any of the purposes or the attainment of

any of the objects herein enumerated or incidental to the powers herein made or which shall at any time appear conducive or expedient for the protection of benefit of the Limited Liability Company.

No recitation or declaration if special powers or purposes herein enumerated shall be deemed to be exclusive, but all powers now, or which may be conferred upon Limited Liability Companies under the laws of the State of Florida, are hereby included and prayed for.

In general, to carry on any other incidental business in connection with the foregoing and to have and exercise all the powers conferred by the laws of Florida upon companies of this character.

ARTICLE III

Initial Capital Contributions in the amount of \$ 1,000.00 shall be paid or delivered to the Limited Liability Company by the members. Additional contributions will be made as required for investment purposes, as determined by unanimous consent of the members.

ARTICLE IV

All of the Limited Liability Company's powers shall be exercised by or under the authority of, and the business and affairs of this company shall be managed under the direction of, the members of this company. This article may be amended from time to time in the regulations of the company by unanimous vote of the members.

ARTICLE V

Management of the limited liability company shall be reserved to its members, whose names and addresses are attached hereto as "Member List".

ARTICLE VI

This Limited Liability Company shall exist until December 31, 2025, or until dissolved in a manner provide by law, or as provided in the regulations adopted by the members.

ARTICLE VII

September 26, 2005


ARTICLE VIII




