**ARTICLES OF DISSOLUTION FOR

These Articles of Dissolution (the "Articles") for Global Prevention Services South Florida, L.L.C., a Florida limited liability company (the "Company") are filed pursuant to the Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"). These Articles are made and entered into effective as the date of filing. The Company and the members hereby state the following:

ARTICLE I.

The Articles of Organization of the Company were filed on September 9, 2005 and assigned Florida document number L05000097023.

ARTICLE II.

Pursuant to the Agreement, Release and Plan of Dissolution and Liquidation entered into on January 3, 2014 between the Company and the members (the "Agreement"), the members have consented to filing the Articles. The members agreed to dissolve the Company due to a deadlock among members regarding the management and operation of the Company. All obligations, liabilities and debts of the Company have been paid or discharged and all remaining Company property has been distributed among the members in accordance with Act and the Agreement. No suits are pending against the Company in any court.

ARTICLE III.
