

**ARTICLES OF ORGANIZATION
OF
NATIONAL WATERGATE LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I: The name of this limited liability company ("the company") is NATIONAL WATERGATE LLC.

ARTICLE II: The initial principal office and mailing address of the company is 3982 Kaden Drive East, Jacksonville, Florida 32277.
