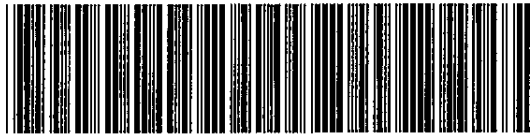

FIRST: The Articles of Organization were filed on OCTOBER 3, 2005 and assigned document number L0500009762.


SECOND: This amendment is submitted to amend the following:
