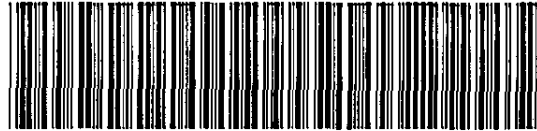

The name of the limited liability company shall be GY Design, LLC.

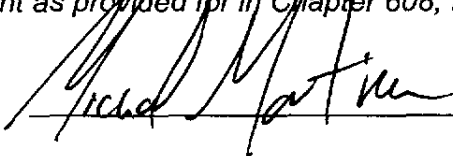
**Article II
